

# METRO WATER IS SAFE TO DRINK

The **Metro Manila Drinking Water Quality Monitoring Committee (MMDWQMC)** in its August 16, 2013 meeting pronounced that the water supplied by **Manila Water** and **Maynilad** at the time of sampling fully complied with the 2007 Philippine National Standards for Drinking Water (PNSDW) based on the microbiological and physico-chemical examination done on water samples collected at strategically designated Regulatory Sampling Points in their respective distribution system in the month of July 2013. In addition, both Manila Water and Maynilad also met and even surpassed the minimum sampling frequency requirement of the 2007 PNSDW for both microbiological and physico-chemical quality.

## *Water supplied by Manila Water and Maynilad in July 2013 is:*

- ✓ **100% Free from disease-causing coliforms**
- ✓ **100% compliant with physical and chemical standards based on examination done on 558 samples taken from East Zone (Manila Water) and 815 samples from West Zone (Maynilad)**

Based on the above findings, the Committee pronounced that drinking water in the Manila Water and Maynilad distribution system was **of Sanitary Quality** with adequate residual chlorine.

The committee further announced that out of 1,081 Water Refilling Stations monitored in Metro Manila for the month of June 2013, **only 1,063 passed** the standards set by PNSDW. Consumers are advised to look for the monthly microbiological quality and semi-annual physico-chemical results POSTED in their 'suki' or 'selected' refilling stations to ensure that the water they buy is **SAFE and POTABLE**.

# TUBIG SA METRO MANILA LIGTAS INUMIN

Sa pagpupulong ng **Metro Manila Drinking Water Quality Monitoring Committee (MMDWQMC)** noong ika-16 ng Agosto 2013, masusing nasuri at idineklarang ganap na sumusunod sa 2007 Philippine National Standards for Drinking Water (PNSDW) ang tubig na kinolekta mula sa suplay ng **Manila Water** at **Maynilad**. Ang deklarasyon ay ayon sa ginawang pagsusuring microbiological, pisikal at kemikal na aspeto ng tubig mula sa kaukulang sampling points sa kani-kanyang water system nitong buwan ng Hulyo 2013. Bukod dito'y nalampasan din ng Manila Water at Maynilad ang takdang bilang ng mga samples para sa mga naturang aspeto.

**Ang tubig mula sa Manila Water at Maynilad sa buwan ng Hulyo 2013 ay:**

- ✓ walang coliform na maaaring magdulot ng sakit
- ✓ ganap na sumusunod sa pamantayang pisikal at kemikal mula sa 558 samples galing sa area ng Manila Water at 815 samples mula sa area ng Maynilad

Ayon sa mga naisaad na pagsusuri, idineklara din ng MMDWQMC na ang tubig mula sa pasilidad ng Manila Water at Maynilad ay **LIGTAS at MALINIS** at may sapat na residual chlorine.

Idineklara din ng MMDWQMC na **tanging 1,063 sa 1,081 Water Refilling Stations** sa Metro Manila na sinuri sa buwan ng **Hulyo 2013** ang pumasa sa pamantayang itinakda ng **PNSDW**. Pinaalalahanan ang publiko na palaging hanapin ang buwanang microbiological quality at kalahating taunang physico-chemical results na marapat na nakapaskil sa mga 'suki' o 'selected' refilling station para masiguradong ligtas at maiinom ang tubig na kanilang binibili.
